Pricing:

- Wash & Fold: \$2.30 - \$1.50 per pound (no minimums).
- Special Items: Duvets, comforters, shoes, and pillows are charged \$5-\$20 based on size, weight, and thickness.

Pricing is subject to change. Customers will be notified in advance of any updates.

Pick-Up & Drop-Off Schedule:

- Pick-Up Times: Every Friday and Saturday after 11:00 AM.
- Drop-Off Times: Every Saturday and Sunday.

Location:

- Leave laundry at your door for collection, or request a knock for hand-off. Alternatively, you may provide consent for entry to collect or drop off items at your apartment entrance.

Delays:

Pick-ups and drop-offs depend on delivery personnel availability. Delays may occur during peak service periods or due to high demand. Laundry Day NYC LLC will not be held responsible for any inconvenience or liability caused by such delays.

Payment Terms:

- Stripe Payments: Secure payment links are included with each invoice.
- AutoPay Enrollment: Automatically activated after your first use (opt-out available).
- Prepayment Option: Prepay and use credits for future services.

Payment Deadlines:
